#### Office Memorandum

Subject: - Dissolution of Ordnance Factory Board and transfer and assignment of existing and subsisting contracts and agreements of Ordnance Factory Board (including its units) to new Defence Public Sector Undertakings and Directorate of Ordnance (Coordination & Services).

In pursuance of the decision of the Union Cabinet on 16<sup>th</sup> June, 2021, the Government of India has decided to corporatise the functions of the 41 production units (Ordnance Factories) of the Ordnance Factory Board ("OFB"), functioning under the Department of Defence Production, Ministry of Defence ("DDP"). Accordingly, the undersigned is directed to state that the Government of India has decided to transfer, with effect from 1st October, 2021 ("Appointed Date"), the management, control, operations and maintenance of these 41 production units and identified non-production units to 7 Government companies (wholly owned by the Government of India), namely (i) Munitions India Limited, (ii) Armoured Vehicles Nigam Limited, (iii) Advanced Weapons and Equipment India Limited, (iv) Troop Comforts Limited, (v) Yantra India Limited, (vi) India Optel Limited, and (vii) Gliders India Limited (collectively "New DPSUs") in respect of (a) production activities, viz production of arms, ammunitions, weapons, vehicles, defence equipment and non-defence equipment; and (b) identified non-production activities, as set out in **Annexure** A. The Government of India has also decided to transfer, with effect from the Appointed Date, the management, control, operations and maintenance of certain identified non-production units of OFB and identified surplus land at 16 production units of OFB to the Directorate of Ordnance (Coordination & Services) ("Directorate") under the DDP, as set out in Annexure B. The New DPSUs have been incorporated as Government companies (wholly owned by the Government of India) with limited liability by shares under the Companies Act 2013 with registered office and corporate offices as set out in Annexure A.

2. Accordingly, on and with effect from the Appointed Date, OFB, which has been set up vide Ministry of Defence letter no. 1(82)/78/D(Fy.I) dated 09.01.1979, shall cease to exist as a body.

- The Government of India has decided to transfer all assets and liabilities, 3. to the New DPSUs and the Directorate as per the structure set out in Annexure A and B, with effect from the Appointed Date. All the existing contracts, agreements, deeds, purchase orders and Memorandum of Understandings entered into by OFB or any of its production and non-production units with various suppliers, contractors, vendors, companies, Organisations and individuals in respect of supply of plant and machinery, raw materials, purchase of land and building, Transfer of Technology and supply of services or any other arrangement, subsisting on date of transfer of business and/or required for operations of the New DPSUs and Directorate (as per the structure set out in Annexures A and B) and with subscribers of all types of services to be provided by the New DPSUs and Directorate, will also stand transferred to the New DPSUs and the Directorate (as per the structure set out in Annexures A and B) with effect from the Appointed Date. The New DPSUs and the Directorate will be solely responsible for honouring these contracts, agreements, deeds, purchase orders and Memorandum of Understandings for their due performance and in case of disputes to sue and be sued as the successor/assignee under the contracts, agreements, deeds, purchase orders and Memorandum of Understandings.
- 4. The New DPSUs and the Directorate will file suitable, required appearances / memos in all pending cases before the courts, tribunals, arbitrators, adjudicators in all matters pertaining to their businesses / units (as per the structure set out in Annexures A and B) except issues of policy making which are with the DDP. The New DPSUs and the Directorate may get substituted or become an additional party as the case may be, or just conduct the cases as assignee or successor in interest of Government / DDP, as permissible. This may, in so far practicable, be completed by 31st December, 2021.
- 5. In respect of matters pertaining to personnel (Government employees) pending before various administrative tribunals, High Courts and Supreme Court, the New DPSUs will be responsible to defend as assignee or successor in interest as per existing rules till the time employees are on deemed deputation with the New DPSUs and protect the interests of the Union of India, except those pending matters being defended directly by OFB HQ at present (which would be defended by the Directorate).
- 6. Any judgement/order/award delivered by an authority / tribunal / court / arbitrator in respect of all the matters described there shall be implemented in letter and spirit by the New DPSUs and the Directorate (as applicable), in accordance with rules, regulations, directions and statutes.
- 7. These orders will come into effect from 1<sup>st</sup> of October, 2021 (Appointed Date.)

8. A Compliance Report regarding implementation of the aforesaid decisions/directives would be submitted to DDP by the new DPSUs and the Directorate by 31.12.2021.
